99.7 Housing Update:-

Cllrs Broad and Whitehurst met with CWaC Housing, West Cheshire Homes and Muir Housing Limited.

Failures were identified in the current application and bidding processes. All three organisations have gone away to review and / or amend their procedures.

A follow up meeting is planned before the next phase of affordable housing becomes available.

A number of residents who expressed interest at the January Village Housing day were not able to obtain property on West End Farm development, although all 10 properties have been allocated to local people.

Issues identified for action by the Council include:-

- (i) Encouraging/helping local residents to register with West Cheshire Homes. Cllr Whitehurst has produced an information leaflet that dispels the myths and gives the facts which will be circulated to the village.
- (ii) The process and rules around discount house sales Further investigation needed.
- (iii) The number of affordable properties to be built in Malpas when viewed against the apparent demand (Data from Ward Survey held by The Malpas and District CLT). Considering this data, Cllr Whitehurst plans to challenge the numbers and types of affordable housing being built in the village.

100 BOVIS - BUS SHELTERS

The Clerk and Cllr Broad held a site meeting with CW&C to discuss the options for the bus shelter which Bovis have to provide under the section106 agreement. At the meeting, a request was made for the funds allocated for the bus shelter to be reallocated towards traffic calming measures on Chester Road.

Cllr Broad has spoken with the developers and they are happy for it to be used for other measures relaying to traffic calming.

A working group of Cllrs Webb, Broad, Lowick Higgie, Hancock and the Clerk are to meet to discuss the proposed volunteer event which is due to take place on Thursday 20th October.

109 CHRISTMAS

109.1 To receive report and agree action:-

Residents and businesses are invited to contact the Clerk should they wish install and pay to have a Christmas tree holder outside their properties.

The Christmas event is due to take place on Saturday 26th November. There will be a grotto at the Christmas Market followed by an umbrella parade leading to the carol service in St Oswald's Church. Father Christmas and his reindeers will be present along with further guests.

The Council formally thanked Cllr Shackleton for his work in organising the event.

109.2 To consider request to pay for fake for Christmas Trees and lights to go up in the village:-

Cllr Shackleton updated the meeting regarding £2,000.00 due in donations to pay towards two sets of Christmas lights.

Resolved:- The Council agreed to purchase fake 4 foot Christmas trees on behalf of the businesses and residents at a cost of approximately £45.00 per tree. Proposed by Cllr Shackleton and seconded by Cllr Webb.

111 LOCALITY COMMISSIONING

Cllrs Webb and Whitehurst attended an event regarding Locality Commissioning Shropshire – Parish Clustering which was about Malpas residents using services in Whitchurch (e.g. library, swimming pool etc) and to request that neighbouring parishes increase their precept to help supplement the services.

The Council are not minded to continue with ongoing discussions.

112 RURAL SUPPORT GRANT

The Council intends to submit a request to CW&C Rural Funding Programme for a £7,000.00 grant towards a community minibus (see item 110).

113 GRASSED AREA IN SPRINGFIELD AVENUE

A request has been received for the provision of additional car parking spaces at the grassed area in Springfields Avenue Highways have been contacted to advise of costs and of the feasibility to convert part of the grassed area to provide parking. They have sent a proposed plan and have advised that provision could be made for 7 extra 'well' parked vehicles with the removal of around 113m² of verge. However, it is likely there would be issues with buried services at the site.

If this is the case, then the services would need to be diverted which would make the scheme expensive, running into several thousands of pounds.

Resolved:- The Council agreed not to proceed with the investigation at this moment in time due to financial constraints.
