166.4 To receive planning updates:-McCarthy Stone have submitted information requested in respect of car parking. Updated drawings for the proposed site have been submitted to CW&C which includes a revision of the car parking layout which has increased the spaces by two. They are prepared to pay £10,000.00 towards highways improvements with speed control measures in the form of a vehicle activated speed warning sign on Whitchurch Road. Resolved: - The Council agreed to write and request that the £10,000.00 that has been allocated towards highways improvements be used instead RS towards installing a raised pedestrian crossing in the interests of pedestrian safety. Proposed by Cllr Shackleton and seconded by Cllr Broad. 166.5 Bovis:-At the monthly meeting the Council received an update regarding the delay with the flooding works at the site which means that Bovis are unable to progress onto phase two. No Man's Heath and District Parish Council have expressed concerns regarding construction traffic going through No Man's Heath to make deliveries to the site. The Clerk agreed to act as the liaison with regard to any concerns / complaints. Plus Dane have been named as the affordable housing provider at the site. Resolved:- The Council agreed to invite Plus Dane to attend a Council RS meeting. Proposed by Cllr Broad and seconded by Cllr Webb. 166.6 Planning Meeting:-Cllr Meredith has agreed to take the lead with the Planning working group and prepare the Planning Reports. 166.7 Planning Protocol:-The Council considered the Planning Protocol consultation from CW&C Planning Department. Resolved:- The Council welcomed the document. Comments to be forwarded as part of the consultation are as follows:-• To request that paper copies of documents and plans are still sent out with all planning applications ending in the code FUL. • That planning applications ending with the codes EXT, COU and LBC be dealt with electronically. Proposed by Cllr Broad and seconded by Cllr Waddelove. 166.8 Public Path Diversion Order:-Notification of confirmation for order CW&C Public Footpath No 1 (part Overton) Public Path Diversion Order 2016 has been received. 166.9 Housing Update:-Nothing to report. 167 BOVIS - BUS SHELTERS The 278 agreement states that the funds must go towards the provision of a bus shelter and cannot be used for other purposes. The Council are to request that the footpath from the site be extended in front of the BT exchange through the Fire Station car park to Leech Lane and to reverse the locations of the bus shelter and bus stop so as the bus shelter is located on RS Springfields and the bus stop on Chester Road. **HIGHWAYS** 168

168.1 Chester Road signage for 30mph flashing sign:-

Confirmation has been sent to Highways to advise that the Council agree to accept the quote of £8,558.00 to install two sign assemblies and extend the

mains supply across Chester Road for two vehicle activated '30' signs with a SLOW DOWN safety message. The quote includes a 10 year inspection and maintenance. Should the Council wish to proceed with the scheme CW&C would require a contribution of £6,787.00. Cllr Whitehurst has agreed to contribute £6,730.00 towards the cost from his members' budget. Highways have replied to advise that arrangements will be made for a works package to be submitted to their contractor.

168.2 Church Street:-

The Council considered putting yellow lines alongside St Oswald's Church Yard wall and discussed various options.

The Clerk is to contact Highways to ask about extending the parking bays further up Church Street to the steps outside Market House and to ask what other alternatives are available.

The Clerk is to contact Highways to enquire about replacing the single yellow line with double yellow lines at the junction of Church Street and High Street.

168.3 Church Street / Wrexham Road:-

The Council considered the introduction of single lines to enable passing places on Church Street and Wrexham Road (towards Sports Club). The Clerk is to request clarification from Highways.

168.4 Whitchurch Road:-

The Council considered requesting the extension of 30 mph speed limit restriction to the turning for Higher Wych just beyond the Mosslands. The request has been forwarded to the Road Safety Engineering team and will be back in touch after they have completed the speed limit assessment.

168.5 Mastiff Lane:-

The Council agreed to explore the possibility of installing a mirror on at the end of Mastiff Lane.

168.6 Chester Road parking bay:-

The Council agreed to request that CW&C extend the parking bays on Chester Road and to install double yellow lines around the junction with High Street as per plan.

168.7 Tilston Road / Recreation Ground:-

The Council considered parking, traffic controls and installation of a pedestrian crossing.

When the development at West End Farm has been completed traffic calming measures are due to be implemented on Hughes Lane. This will include the relocation of the Recreation Ground Pedestrian entrance.

The Council agreed to explore road safety options available at the location with CW&C and at the same time request that an assessment in undertaken for a pedestrian crossing.

168.8 Wrexham Road:-

The Council considered installing vehicle activated '30' signs.

Highways have advised that of the count information from a counter located within the length of Wrexham Road subject to a 30 mph speed limit. The results showed that the majority of drivers exceeded the speed limit at the survey point with average speeds of 35.6 mph for westbound traffic and 34.8 mph for eastbound traffic.

Given these speeds match funding would be available for vehicle activated '30' signs should the Parish Council wish to pursue this option. 50% match funding would be required.
