253 DECLARATION OF INTERESTS

Cllr Whitehurst declared a non-pecuniary interest in items 268 and 269 of the minutes.

254 APPROVAL OF THE MINUTES

Resolved: - The Chairman signed the minutes of the Parish Council meeting that was held on 9th January 2017 as a true and proper record. Proposed by Cllr Webb and seconded by Cllr Shackleton.

255 OPEN FORUM

- 255.1 Mark Groves, Service Manager at the Royal Voluntary Service Cheshire, informed the meeting about the Buddy Scheme that has been set up in conjunction with Brightlife in Malpas and to make a request for volunteers to support the scheme.
- 255.2 Ben Kavanagh and Trish Cheung, representing the Plus Dane Group, spoke to the meeting about the Affordable Home Ownership properties at the Bovis site, Chester Road, Malpas. Five properties are due to be available shortly (3 x three bedrooms and 2 x two bedrooms). The properties have been advertised; out of the 34 bids received there were 2 bids from the local area. Posters are to be put up in the village with all the relevant contact details for the rental properties and the affordable properties.
- 255.3 Stan Hopley raised various queries concerning the allotments. These included:-site security; public liability insurance; water supply; planting of trees at the site; responsibilities of the tenants; whether greenhouses and / or polytunnels are permitted at the site; request for dedicated point of contact with the Council. Cllr Shackleton has already agreed to act as liaison between the Council and allotment holders and is due to arrange a meeting with the allotment holders to set up an allotment society.
- 255.4 Patrick Lomax, LA Planning, spoke to the meeting about the ancient ditch at the Mount View Development, Church Street, Malpas.

256.1 Report:-

PCSO Jon Hurst updated the meeting as follows:-

- The Cedars:- Cllrs Whitehurst and Webb have met with McCarthy Stone to look at the redesign of The Cedars. They may yet appeal against the decision.
- The Beeches:- Complaints have been received from residents regarding lack of pavements at the site, knotweed at the site and the state of the roads. The developers have agreed to a temporary footpath until the new one is laid through the site and to clean the roads as and when required.

262.5 Bovis:-

The Council are due to meet with Bovis Homes. Matters to be raised include:drainage concerns; noise from generator and mud on roads throughout the village.

263 HIGHWAYS

263.1 Chester Road:-

CW&C are progressing the road signage for 30mph flashing sign

263.2 Church Street / Wrexham Road:-

See item 261.1 for update regarding introduction of parking restrictions.

263.3 Whitchurch Road:-

CW&C are due to carry out a survey in relation to extending the 30 mph speed limit.

263.4 Old Hall Street:-

The Council considered whether to support the introduction of prohibition of waiting restrictions to improve conditions for turning manoeuvres at the access to the Doctor's surgery with Old Hall Street and agreed to defer a decision at this present moment in time.

263.5 Bridleways and Footpaths:-

The Public Rights of Way Officer is due to visit the village to see the state of the bridleways and footpaths caused by damage and / or neglect and to prepare a plan of improvements.

263.6 General State of Pavements and Roads:-

The Clerk is to submit a request a deep cleanse of the village to CW&C.

263.7 Mastiff Lane:-

A letter has been sent to the land owners to request permission to install mirror opposite junction with Mastiff Lane.

264 BOVIS - BUS SHELTERS

Cllr Whitehurst updated the meeting regarding locations and styles for a new bus shelter on Springfields. Cllrs Whitehurst and Waddelove are to circulate recommendations to the Council.

265 ALLOTMENTS

The works at the site are yet to be carried out. The Clerk is to obtain quotes to carry out the work. Once the works have been completed the Council agreed to re-advertise the plots to residents of the parish of Malpas before accepting offers to rent the plots from outside the parish.

A meeting with the allotment holders to set up an Allotment Society is to be arranged which will address the concerns that were raised in the Open Forum.

266 PARISH INFORMATION BOARDS

A proof has been circulated to Cllrs for any additional amendments to be added to the ones already indicated.

The Council previously agreed to order three black stainless steel framed A1 noticeboards.

Two of the noticeboards containing the map are to be located at the following locations:-

- High Street car park;
- Chester Road;

The third noticeboard is to be located at St Oswald's Church. Work is due to start on the design.

267 VILLAGE WELCOME SIGNS

A picture of St Oswald's Church has been circulated to Cllrs. Mr Patrick Lomax offered to carry out the work to 'brighten' up the picture.

268 MALPAS COMMUNITY LAND TRUST

Resolved:- The Council agreed to nominate Cllr Woolam to act as the parish council representative to represent the council's view on the newly formed Malpas Community Land Trust Board. Proposed by Cllr Webb and seconded by Cllr Hancock.

269 COMMUNITY MINIBUS

269.1 To receive update:-

Cllr Webb updated the meeting regarding the grant application.

269.2 Letter of Support:-

The Council approved the letter of support in respect of the Rural Grant bid.

270 NEIGHBOURHOOD PLAN

Resolved:- The Council agreed to establish a working group to upgrade the Neighbourhood Plan consisting of Cllrs Whitehurst, Webb, Meredith, Thomas, Norris and Barnett. Proposed by Cllr Shackleton and seconded by Cllr Thomas.

271 BUNTING ON HIGH STREET

There is still some bunting that is yet to be removed from the High Street. The Council expressed concern about the cost to repair the Jubilee clock which was damaged by the bunting. The Council discussed reducing the grant to the Village Fair Committee to compensate for the repair costs and hire of cherry picker.

272 SYCAMORE TREE AT THE OX HEYES

The Council are to look into the cost to replace the sycamore tree at Ox Hayes with an oak tree. The Clerk is in the process of contacting the Church of England who own the land.

273 PROMOTING TOURISM IN MALPAS

The Council agreed in principle to consider a possible bid for funding to promote tourism and to work with neighbouring villages / parish councils / tourist attractions.

| (i) | Jubilee Clock | Damage to the clock was caused by the bunting. Smith of Derby have now repaired the clock and the bunting has been removed. |
| (ii) | Grants | The clerk has written to applicants to advise that the Council received grant requests totalling £14k and that the Council have allocated a maximum of £8k in respect of grant payments. They are to be considered at the May meeting. |
| | Tilston Road | Complaint received regarding the state of the road at Brockbank Cottages as very muddy and dangerous for pedestrians and vehicles. Reported to Highways |
| (iv) | Charities Commission | The Annual Return for the year ended 31/03/16 has been completed online. |
| (v) | Springfield Road | The Council has received a request to widen road round the green in Springfield Road. Highways have advised that technically it is possible to widen any road, but as the road widening here is to facilitate cars parking, it is unlikely that it would be funded from CW&C's maintenance budget. The issue is that if cars park on the road around the green, they obstruct other traffic, even when the cars park fully on the footway and block its use to pedestrians. While the erection of bollards would protect the green from being overrun by vehicles, an obstruction would still occur whenever vehicles were parked on the road, and it is unlikely to deter drivers who fully park on the green. This leads to two courses of action; widen the road by 1 – 2 m or prohibit parking. Depending upon the cost of moving the services it is likely to cost between £30,000 and £40,000 to widen the road. If parking were prohibited residents may be encouraged to install vehicular crossings so they could park in their own curtilage. The cost of installing the crossings to those properties who do not already have them would however need to be met by the applicant. |
