75.1.1 23/00042/ENF - NATURE OF APPEAL: The change of land from agricultural to residential, the siting of three caravans for residential occupation in connection to the residential use of the land at Land Off Overton Heath Lane Malpas

Observations:-

The Council objects to this appeal after careful consideration of the observation given below, and would ask the Planning Inspectorate to dismiss the appeal.

If the Planning Inspectorate is minded to allow this appeal the application the Parish Council would request that the following conditions be included:

- That the site in question is cleared of scrap vehicles, tidied up and all non-agricultural items removed.
- That the caravans/dwellings are conditioned for rural workers at this site in perpetuity Background Factors: Open countryside

Relevant Local Plan Part 1 Policies: Strat 9

Relevant Local Plan Part 2 Policies: DM19

Material considerations against development:

Potential impact on neighbours: Unsightly outlook in the public domain

Visual, noise and air pollution. Ground contamination.

Potential impact on wider community: Unsightly outlook in the public domain.

Visual, noise and air pollution. Ground contamination.

Urbanising of the open countryside

Other relevant information for consideration:

The Parish Council understands that there were some family relationship issues that have potentially led to the current situation.

However, the Parish Council would strongly object to upholding this appeal on the observations recorded below.

The clutter and menagerie on this site represents a complete "blot on the landscape" of what was once a peaceful rural agricultural setting. (See overall aerial view of the site)

One of the fields in the appellant's ownership has been observed to be covered in ragwort. (Field Area 1 on accompanying map.)

The entrance being used to access the site is off the Bishop Bennetts Bridleway which is designated as a Triple SSSI site, and a local wildlife site.

The site is visible from the Public Right of Ways, Bishop Bennett's Way and Footpath Malpas FP8. (See accompanying photographs in Appendix A.)

The Parish Council would like to know how many people are currently living on the site and in what accommodation?

If there is a proven need for residents to be located near to the site, then there is an existing registered caravan park located just ½ mile away at Alport Farm, Overton Heath Lane, Overton Common, Malpas, Cheshire, SY14 7DG.

Overton Heath Lane that could provide adequate accommodation for any essential rural workers.

Local Plan part 1: This location of the appeal site is covered by Strat 9 of the Local Plan Part 1 which states:

Strat 9 - Green Belt and Countryside

The intrinsic character and beauty of the Cheshire countryside will be protected by restricting development to that which requires a countryside location and cannot be accommodated within identified settlements.

Within the countryside the following types of development will be permitted; Development that has an operational need for a countryside location such as for agricultural or forestry operations.

Replacement buildings.

Small scale and low impact rural / farm diversification schemes appropriate to the site, location and setting of the area.

The reuse of existing rural buildings, particularly for economic purposes, where buildings are of permanent construction and can be reused without major reconstruction.

The expansion of existing buildings to facilitate the growth of established businesses proportionate to the nature and scale of the site and its setting.

Development must be of an appropriate scale and design to not harm the character of the countryside.

The general extent of the North Cheshire Green Belt will be maintained. Policy 'STRAT 3 Chester' sets out the proposed release of Green Belt to meet the development needs of Chester.

In settlements and areas of the countryside that are within the Green Belt, additional restrictions will apply to development in line with the National Planning Policy Framework."

In this respect the said development does not meet any of the conditions of Strat 9. Policy DM 19 (Proposals for residential development) of the West Cheshire Local Plan Part 2 states

- That there is good access to public transport;
- it is located within reasonable walking distance of local services and facilities along a safe route:
- there would be no greater impact on the character of the countryside;
- it would result in an enhancement of the site and the rural setting; and
- the design and layout of the development fully reflects the rural character of the area
- and does not 'urbanise' the countryside.

It is considered that 3 caravans plus the other non-agricultural items located in open countryside on this site have a huge urbanising effect on this rural setting.

Policy H2 of the Malpas and Overton Neighbourhood Plan states that "Development of individual homes in rural area will be considered acceptable if they provide replacement dwellings"

This development clearly does not provide replacement dwelling.

Policy H2 then goes on to say that

"They will be considered appropriate if they meet specific needs and deliver high standards of design and sustainability in accordance with the following criteria: -

- Required for rural workers in their place of work in this case it must apply in perpetuity
- New dwellings will be considered appropriate if they deliver homes off an exceptional,

innovative design.

Design must be truly outstanding or innovative, demonstrating the highest standards in architecture and helping to raise the design standards in the rural area.

The design must also be sensitive to the defining characteristics of the local area "Again, the location of three caravans on this site does not comply with the policy. The Parish Council have strong concerns about the provision of 3 caravans in this location.

They would question as to what essential services are available i.e.:

Electricity Supply: (Electricity produced by generators will result in constant noise pollution from portable generators.)

Fresh Water Supply: Where is this fed from?

Foul Water and Sewerage Management: Without a proper SUDS system it is likely that pollution will impact on the Triple SSSI designated site and other adjacent farmland.

The Council like CW&C, has declared a climate emergency and would expect all proposals for new developments, extensions or alterations to recognise this, specifically by ensuring properties are at least carbon neutral, avoiding the use of fossil fuels and have facilities for the charging electric vehicles.

75.1.2 23/01599/LBC - Replacement front first floor window at The Tithebarn Church Street Malpas

Observations:-

The Council would make the observations as documented below:

Background Factors: Within settlement boundary; Conservation area; Listed Building Relevant Neighbourhood Plan Policies: BE3, SF2

Other relevant information for consideration: The Council like CW&C, has declared a climate emergency and would expect all proposals for new developments, extensions or alterations to recognise this, specifically by ensuring properties are at least carbon neutral, avoiding the use of fossil fuels and have facilities for the charging electric vehicles.

Proposed by Cllr Shackleton and seconded by Cllr Higgie.

75.2 To consider any applications received after the agenda has been distributed:-23/01774/CAT- Yew (T8, T9) - Crown lift to 2.5m over footpath at St Oswalds Church Church Street Malpas

Observations:-

Malpas Parish Council objects to this application after careful consideration of the observation given below.

Background Factors: Within settlement boundary; Conservation area; Listed Building Relevant Neighbourhood Plan Policies: LC1 and LC4 Potential benefits to the community: None identified

Potential impact on neighbours: The removal of any part of a healthy living tree will result in a reduction of carbon capture capability and is likely to cause an increase in pollution in the local area.

Potential impact on wider community: The removal of any part of a healthy living tree will result in a reduction of carbon capture in the area leading to an increase of polluted air in the vicinity.

Other relevant information for consideration

Malpas Parish Council do not support the removal, cutting back of any healthy living tree unless it poses a danger to life.

The Council objects to this application on the basis that the individual yew trees do not pose a risk to life, and are making a vital contribution to area's carbon reduction.

Yew Trees (*Taxus baccata*) are a slow growing, long-lived native evergreen tree.

The Yew is a medium-sized, evergreen tree commonly found in churchyards.

This association with Christian religion (and possibly even older beliefs) and its ability to reach extreme old age have ensured that Yew is now surrounded by many myths. In fact, the dead were sometimes buried beneath Yew trees to 'protect' them.

It is therefore highly likely that these Yew trees are at least as old as St Oswald's church itself. (14th Century)

These ancient Yew trees in St Oswald's Churchyard provide a home for many wildlife species.

Any cutting operation will result in the trees taking years to recover.

The Council like CW&C, has declared a climate emergency and would expect all proposals for new developments, extensions or alterations to recognise this, specifically by ensuring properties are at least carbon neutral, avoiding the use of fossil fuels and have facilities for the charging electric vehicles.

Proposed by Cllr Shackleton and seconded by Cllr Higgie.
